<p>Vehicle owner or purchaser will receive a new certificate of title, a five year registration and Horseless Carriage license plate upon proper completion and submission of:</p> <ul style="list-style-type: none"> Form MVD-10056 Application for Horseless Carriage Certification Proof of Insurance or Financial Responsibility Title and Registration Fee of \$14.50 Do not send cash. Completed Engine or Secondary Number if different than primary Vehicle (VIN) Identification Number <p>The initial registration is valid for five years.
