## INSTRUCTIONS

---

COMPLETE APPLICATION FOR VESSEL TITLE AND REGISTRATION IN ITS ENTIRETY.  
PLEASE TYPE OR PRINT LEGIBLY

All motorboats propelled by machinery or sail (except windsurf boards and sail boards) must be **registered**. All motorboats (boats) ten (10) feet in length or longer must be **titled and registered**. Motorboats are registered for a three (3) year period and registration expires December 31st of the third calendar year. There is no refund of fees if vessel is sold, transferred, abandoned, destroyed or unused. Motorboats being registered for the first time, unless the originating document is a Manufacturer's Statement of Origin (MSO), and motorboats without a Hull Identification Number must be inspected.

New Mexico Registration Numbers and/or Hull Identification Numbers (HIN) will be assigned, if necessary, by the Motor Vehicle Division. **If the vessel's HIN does not meet Federal Coast Guard requirements in 33 CFR Part 181, a new HIN may be assigned. This includes HIN's previously assigned by New Mexico prior to April 1, 2022.**

## PENALTIES

---

**LATE TRANSFER PENALTY:** There is a Late Transfer Penalty of \$20.00 for not transferring a New Mexico titled boat within thirty (30) days from date of purchase.

**LATE TITLE PENALTY:** A penalty of fifty percent (50%) of the excise tax is assessed if a boat is not titled within ninety (90) days from date of purchase.

## FEES

---

DOCUMENTS AND FEES MUST BE PROCESSED BY A MOTOR VEHICLE DIVISION FIELD OFFICE.

**TITLE FEE:** Ten Dollars (\$10.00)

**REGISTRATION FEES:**

Class A - Under 16 Feet in Length .....	\$28.50
Class 1 - 16 Feet to Less Than 26 Feet .....	\$36.00
Class 2 - 26 Feet to Less Than 40 Feet .....	\$43.50
Class 3 - 40 Feet to Less Than 65 Feet .....	\$51.00
Vessels over 65 Feet .....	\$66.00

**EXCISE TAX:** Five percent (5%) of sales price less trade-in. Applicable to boats 10 feet in length or longer. Credit is given for any tax paid to another state. Gross receipt tax applicable to motorboats under 10 feet.
