<p><b>** What if my name is different than what is listed on my proof of identity?</b> You will need to present one or more of the following documents that show a clear trail of name changes.</p> <ul style="list-style-type: none"> <li>• Marriage Certificate(s)</li> <li>• Divorce Decree(s) must list previous name</li> <li>• Adoption Records</li> <li>• Court Order(s) for name change</li> </ul> <p>* Must be original or certified copies</p> <p><b>One (1) of the following:</b></p> <p><b>1) United States <u>Original</u> or <u>Certified Copy</u> of Birth Certificate</b> *issued by that states Vital Statistics</p> <p><b>2) U.S. Passport or U.S. Passport card</b> (both must be valid)</p> <p><b>3) Consular Report of Birth abroad</b> issued by U.S. Dept. of State forms:</p> <ul style="list-style-type: none"> <li>• FS-240</li> <li>• DS-1350</li> <li>• FS-545</li> </ul> <p><b>4) Documents issued from Department of Homeland Security or U.S. Citizenship &amp; Immigration Services</b></p> <ul style="list-style-type: none"> <li>• Permanent Resident Card I-551</li> <li>• Certificate of Naturalization DHS N-550 N-5670</li> <li>• Certificate of Citizenship DHS N-560 N-561</li> </ul> <p>* Must verify through Systematic Alien Verification for Entitlements System (SAVE)</p> <p><b>*** Documents presented must be valid and unexpired.</b></p>	<p><b>One (1) of the following:</b></p> <ol style="list-style-type: none"> <li>1) Social Security Card</li> <li>2) W2 Form</li> <li>3) SSA-1099</li> <li>4) Non-SSA 1099</li> <li>5) Paystub</li> </ol> <p><b>** Documents in this category presented as proof of your Social Security Number must include the full and complete Social Security Number</b></p> <p><b>*** All documents presented must be Original or Certified Copies</b></p> <p><b>**** All documents must be legible. Faded, torn or taped documents that obscure required information cannot be accepted</b></p> <p><b>***** Name on social security card must match name on identity documents.</b></p> <div data-bbox="695 1871 902 1982" style="text-align: center;"> </div> <p style="text-align: center;">Version 05/25/2023</p>	<p><b>Two (2) of the following and MUST include applicant's name and <u>physical</u> NM address:</b></p> <p>Real property rental or purchase agreement <b>*Must be current</b></p> <p>Local Property Tax Document <b>*Must be most current issued by County Assessor</b></p> <p>City, County, State, Tribal or Federal document attesting to NM residency including E911 verifications are acceptable for a period of one year from date of issue;</p> <p><b>The Following documents must be dated within 60 days</b></p> <ul style="list-style-type: none"> <li>• Utility Bill which includes water, gas, electric, propane, internet, cable, satellite, phone (does not include cell phone bills)</li> <li>• Bank, Credit Card or Mortgage Monthly Statement</li> <li>• Employment Pay stub, SSA Benefit Verification Letter</li> <li>• Education Institution Document which include a transcript, report card or enrollment confirmation</li> <li>• NM Medical Assistance Card with Letter from issuing agency that came with card showing name and address <b>OR</b> profile print out from issuing agency <b>OR</b> benefit award letter showing current benefits.</li> <li>• NM Public Assistance Card with letter from issuing agency that came with card showing name and address <b>OR</b> profile print out from issuing agency <b>OR</b> benefit award letter showing current benefits.</li> <li>• Document evidencing eligibility and proof that the applicant is currently receiving services from a non-profit organization qualified pursuant to Section 501 (C) (3) of the Federal IRS Code of 1986 Provided the document displays the applicant's physical address.</li> </ul> <p><b>The following documents dated with 6 months and be unexpired</b></p> <ul style="list-style-type: none"> <li>• Insurance Bill, Card or Binder</li> </ul> <p>*If you are presenting a binder you must be the policy holder</p> <p>**Home, health, life, auto, homeowners and renter's policies are acceptable.</p> <p><b>** Documents showing only a PO Box or HC Address cannot be used</b></p> <p><b>*** Printed paperless statements are acceptable</b></p> <p><b>****If you are married you can present proofs of residency in your spouse's name along with the marriage certificate.</b></p>
